## University of Illinois Supplemental 403(b) Retirement Plan Default Fund Notification

Dear Plan Participant:

Under the University of Illinois Supplemental 403(b) Retirement Plan (the "Plan"), any contributions for which you do not provide investment direction will be invested in the Plan's designated default investment option.

The Fidelity Freedom<sup>®</sup> Fund - Class K6 will become the Plan's designated default investment option effective **October 4, 2019**. Fund descriptions are provided below.

You have the right under the Plan to direct the investment of your existing balances, which includes contributions and any earnings on those contributions, and your future contributions to any of the Plan's available investment options. In the event that you have not made an investment election or the Plan Sponsor has not provided direction for a given contribution, it will be invested into the Plan's designated default investment option, the Fidelity Freedom<sup>®</sup> Fund - Class K6. If your contributions are initially invested in the designated default investment option, you have the right to transfer out of the designated default investment option to another investment option.
