

## HRFE ISSUES ADDRESSED IN THE 9.91 Patch

### **8588 – Visa Type 04**

The Visa Type of 04 (Out of Country/Citiz Unknown) will now only be available in the drop down when the Citizenship is set to NR (Non-Resident Alien) or RA (Resident Alien for IRS only-NR).

### **8801 – Visa Type 05**

A hard error message will appear for the 05 Visa Code if the Citizenship is not set to US (Citizen) or PR (US Permanent Resident (LPR)). The expiration date of 12/31/2222 is still required when entering this Visa Code in the Visa Type field. However, when you are notified of when the employee returns to work in the U.S. a new expiration date reflecting the day before work was performed in the U.S. must be entered. This new date will trigger a warning message that will appear at all route stops informing the user to check for a valid I-9 in Tracker.

### **8803 – Changes to the PAPE# drop down based upon Job Begin Date**

Effective 10/1/2018 the following PAPE's will appear in the PAPE dropdown for B\* e-classes.

- 42002 – RESEARCH
- 42003 – EXTENSION

### **8804: Code changes due to the Xtender 16.3 upgrade**

HRFE coding changes were made to accommodate the changes with the Xtender 16.3 upgrade. You will continue to attach and view documents as you were prior to this patch.

### **8805: Open up the Job Title field for all route stops for the Civil Service employees (C\* and D\* E-Classes)**

All jobs that have an E-Class of either C\* or D\* on the job, the job title field is now editable at all route stops.

**8806 – Remove the Emergency Contact of P (Primary Contact if Missing) from being viewed in HRFE**

The value of P (Primary Contact if Missing) was intended to only be used for Students under the Clery Act and should only be viewable by authorized personnel. Therefore, this value will no longer appear in the HR Front-End.

**8808 – Address the broken link on New Hire emails**

The link in the New Hire emails (to new employees) was sometimes incorrect. A fix was put in place to correct the link.

**8810 – PPACA Status on Employee General Info tab incorrect**

The PPACA Eligible field is not always displaying the correct value derived from the New Hire wizard. When there is an ADD (Add A Job) component, and that component was being viewed, the value was set to 'No' regardless of the status that was derived in the New Hire wizard.
